Hold Harmless Agreement

I (we) agree that Old Dominion Retriever Club (hereinafter ODRC) has the right to refuse any dog(s) from participation in any event for cause which the Club shall deem sufficient. In consideration of the opportunity to participate in any ODRC activity, I (we) agree to hold the ODRC, its members, directors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of their dog(s) while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to their dog(s).
